Petitioners sued respondent, W.R. Griffin, Sr., who at the time of the sale had actual, constructive, and apparent authority to act for this seller. The jury found actual authority and no fraud. We find no evidence supporting the jury's findings of apparent authority and constructive fraud. We will reverse the judgment of the court of appeals and render judgment that petitioners take nothing. The parties bought land in Harris County on July 1, 1974. Griffin acted as the selling agent for the seller. The record is unclear whether Griffin had authority to sell other minerals besides those in question, but we assume he did. In their pleadings petitioners alleged Griffin had actual authority to act as agent for the seller and was acting within the scope of his authority at all relevant times. Griffin by his plea of "no evidence" and "insufficient evidence" denied actual authority. A special issue inquiring if Griffin had apparent authority was submitted to the jury at the close of all of the evidence. The jury found that Griffin had apparent authority and that the apparent authority was not the result of a fraudulent act or omission on his part. Petitioners' first two points of error complain of the lack of evidentiary support for the jury's findings on actual and apparent authority. Petitioners' third point of error complains of an improper argument by counsel for respondent in the presence of the jury. Where, as here, the jury found actual authority, we need not reach the question of apparent authority. A principal who is dealing directly with a third person must use ordinary care and prudence to ascertain whether the agent has authority. The general rule is that if the principal, with knowledge of the agent's lack of authority, holds him out to third persons as having authority, and the third person, believing *288 the agent to have authority, deals with the agent, the principal is estopped from denying

As noted earlier, the menu options for that May 24 gig have been posted up on Venue Nightclub's Facebook page.
